

## Summer Day camp

The Summer Day Camps have been designed to provide a fun and educational experience through the summer months. Twelve weeks of summer have been divided into twelve themes which will be incorporated into daily activities, making each camp experience unique.

Daily activities will be customized for each age group and will include arts and crafts, cooperative play, educational activities, reading, and organized outdoor activities including group games, water activities, sports, bicycling, field trips, and free play.

**Ages:** Pre-K 2 thru 8<sup>th</sup> Grade.

**Times:** Monday thru Friday from 8:00 a.m. to 5:30 p.m.

**Cost:**

\$150 full time per week session

\$ 90 part time per week session (1-3 days).  
Same rate for 1 to 3 days.

No daily rate. Payments are due before child attends each week.

**Things to Bring:**

Snack, bag lunch (with drink) sunscreen, towel, refillable water bottle, a book for independent reading, bicycle, or a scooter and a helmet. Hot lunch is available for an additional fee of \$4.00/child.

## Keeper's Afterschool Program

Keeper's is the school's after school enrichment and care program for students Pre-K2 through 8th grade. It is administered and staffed by employees of the school and runs from 3:00-6:00 PM. Monday-Friday (excluding early dismissal days). Any child who is not picked up by 3 PM will be sent to Keeper's, and you will be billed accordingly.

The base hourly charge for Keeper's is set by the school administration in consultation with the Finance Committee. Upon entering Keeper's, children are checked in and billing for the first hour begins. You will be charged \$4.50 for the first hour as a flat rate. For the second and third hours, Keeper's usage will be charged incrementally by rounding up to the nearest half hour.

Children will remain in the extended care area until they are signed out by a parent or an authorized adult designated in writing by the parent. Children will not be sent alone to the car, and children will not be left alone in the extended care area.

Pick up will be through the cafeteria doors (on the side of the building where the statue is). The door is locked, and keepers staff will let you in to sign out your child(ren).

## Keeper's Snow Day Care

The Snow Day Program is intended to provide a safe, reliable, and fun option for busy parents in the event that school is cancelled due to inclement weather. Below are further details about the program, as well as the procedure for registration.

### Program Details

Snow Day Care is open to children in Pre-K2 through 8th grade. Children must be registered to attend this program.

Registration Fee: \$10 per family

Cost: \$45 / day for one child

\$65 / day for two children

\$90 / day for three or more children

**Note: There will be a \$10 charge per snow day for children signed up for the program who do not use the service. This is necessary to cover the cost of staffing.**

Hours: 8:30 am to 5:30 pm

Children will have access to the gym, cafeteria, and library for a variety of activities. If the weather permits, time will be set aside to play outside; therefore it is suggested that children bring warm jackets, boots, hats, gloves, and a change of clothing.



## Keeper's Snow Day Care

A morning and afternoon snack will be provided as well as hot chocolate to warm up cold children. Hot lunch is available for an additional fee of \$4.00/child. Hot lunch will be billed to your account.
